Project structure and activities

- Target: Cambodian migrant workers in Klong Yai district
 - Mobile Support Team (MST): Three staff (Coordinator, project officer and mobile staff)
 - Two weeks - Migrant Support team based in Klong Yai district
 - Three times a year awareness raising in Takeo and Kampot on safe migration

What has been achieved?

- ❑ Project began July 2005. Cross-border Koh Kong/ Klong Yai border
 - ❑ Establishment of a Migrant Volunteer Support Network (10 Volunteers)
 - ❑ Research on the situation of Cambodian migrant workers (Sept 2005) and survey report of cross-border migration (Feb 2006)
 - ❑ Cooperation with Raksthai Foundation who work on health and HIV/AIDS


Cont.

- Mapping of resources and services in Klong Yai district
 - Capacity building of migrant volunteers and inclusion in national level meetings
 - Lobbying for cross-border cooperation and enforcement of labour and trafficking laws and MOUs (Trafficking and migrant workers)

Awareness raising on rights, laws and legal policies

- Thai registration procedure and Certificate of Identification (CI) and visa process
 - New legal channels of migration through recruitment agencies
 - Thai government decisions on education
 - MOU on employment of workers
 - Child and migrant rights


Awareness raising in port areas in Klong Yai district

Information collected from migrants by the MST

- ❑ Info and data has been collected by the VSN (six month report)
 - ❑ Details of various industries (construction, fishing, fish processing, shrimp peeling, saw-mills, loading and unloading)
 - ❑ Reasons for migrant children's non-attendance at school
 - ❑ Problems and issues faced by Cambodian migrants in KY district
 - ❑ Saving and remitting money
 - ❑ Female migrant workers

Working to Empower Cambodian migrant workers

In eight different villages in Klong Yai district

- ❑ Rights of migrant workers regarding holding of work permit
 - ❑ Rights in regard to Thai Labour Protection Act
 - ❑ Rights of women, children and migrants generally
 - ❑ Information on making a complaint to the Labour Protection Office in Trat
 - ❑ Information on new legal channels and MOU


Thai Labour Protection Act session with fish processors





Findings

- ❑ High percent of young female Cambodian migrant workers under 18 years old
 - ❑ Klong Yai district is transit point for trafficking to other areas of Thailand especially fishermen
 - ❑ Large numbers of migrant children and families
 - ❑ Social problems (drinking, gambling, killings, domestic violence, rape, violence)
 - ❑ Migrants in crisis (abandoned babies, disappearance, debt, irregular work, arrest)

Large numbers of Cambodia migrant children lack access to education





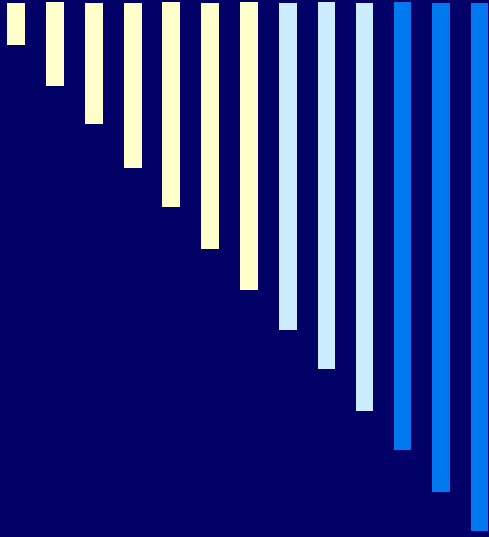
Future activities

- ❑ Establishment of female migrant support groups and fishermen network
 - ❑ Research on Cambodian fishermen
 - ❑ Referral system for migrants in crisis especially serious labour exploitation
 - ❑ Training of Cambodian migrant workers in protection strategies
 - ❑ Cross-border mechanism for returns between Klong Yai and Koh Kong
